Happen Business Network Member Application

Terms & Conditions

Please take a moment to browse the terms and conditions that govern Membership in Happen Business Network.

You agree to join and remain in the Happen Business Network on the following Terms and Conditions:

1. That the Member Company is actively using Jim2 Business Engine in their business, and member company employees have an overall familiarity with Jim2 Business Engine functionality.
2. Happen Business may change these Terms and Conditions at any time and without notice by posting those changes (or changed terms and conditions) on its website.
3. Sales Lead registration time/date governs which Member is entitled to the potential rewards. In the event of two (or more) Members registering the same Sales Lead, only the first (time/date) to register will be entitled to the potential rewards.
4. The rewards payable to you are on a 'per site' basis for Jim2 Business Engine sales that are paid for in full. The rewards are set out on the current Happen Business Network Fact Sheet, and can be changed at any time by Happen Business without notice.
5. If you have specified that you are an Australian resident for taxation purposes then you must also supply to Happen Business a valid Australian Business Number (ABN), and any reward paid to you:

 - II. Will be supported by a recipient created tax invoice issued to you by Happen Business in accordance with the requirements of the GST legislation then in force

If you have not specified your company ABN on the Happen Business Network Membership application, any reward paid to you is exclusive of any goods and services tax and other taxes or charges which may apply to the reward by any relevant law. You must meet the liability for any applicable tax, charge or levy.

6. As a Member of the Happen Business Network you are granted a limited licence to use Happen Business' logos and trade marks. You may use them only in the format provided to you, for the period that you are an authorised Happen Business Network Member and only for purposes connected to the conduct and promotion of the Happen Business Network. 12. Either party may terminate your participation in the Happen Business Network without cause by not less than 7 days notice to the other.
